

# CAMBERSHIP APPLICATION INSTRUCTIONS

*\*\*Camperships average \$200 to \$225; unfortunately we do not have the funds to award more than that.*

Thank you for applying for campership funds for your camper to attend our 2010 Summer Camp. A registration form and a deposit must be received for **EACH applicant** before your camper can be registered for the session(s) of his/her choice.

## **Incomplete forms will be returned to you for completion PRIOR to processing.**

*Please note: Pilgrim Pines Camp is a non-profit, church based organization. We cannot make repeated phone calls to obtain required information, nor can we mail forms multiple times. Please complete campership applications in full and attach all required documentation. Thank you for understanding our need to conserve valuable and limited resources. **I. A \$100.00 minimum family contribution is required with all registrations .  
Please, NO EXCEPTIONS.**

Please encourage your camper in raising money to help pay for a portion of her/his camp experience. Encourage recycling (aluminum cans, bottles, etc.) or a church fund raiser (car wash, etc.) as ways to raise money for camp. Check with your church, public agency, relatives and individuals regarding any campership funds available to assist your camper. *Fill in the amount of money you are paying and all amounts anticipated from all other sources.*

**II. To qualify for a campership, please complete the attached Campership Application Form in full. Eligibility is based on family income. There are two ways that a camper can qualify:**

- 1) Your annual income must be at or below the levels set forth in the chart below. **ATTACH PROOF OF INCOME.**

- 2) Your family is receiving public assistance, such as Foster care, AFDC/TANF, food stamps or receives Medi-Cal. **(You MUST attach a copy of the camper's California Benefits Identification Card in order to be considered. If you do not attach the ID card your application for financial aid WILL BE DENIED).**

**\*\*Social Workers referring foster children MUST PROVIDE each child's foster care number.**

**III. Return the Campership Application Form, the registration forms, proof of income (current pay stubs), or copies of required ID cards, NO LATER than June 1, 2010. IF funding is available after that date applications can be accepted.**

**IV. If the camper resides in a group home please check with any and all public agencies providing financial assistance to see if the camper qualifies for the agency(ies) campership assistance. **Some group home campers do not qualify for assistance from public agencies or regional centers.****
